Flagpole – The bushes under the flagpole have been trimmed to allow the light to reach the flag.

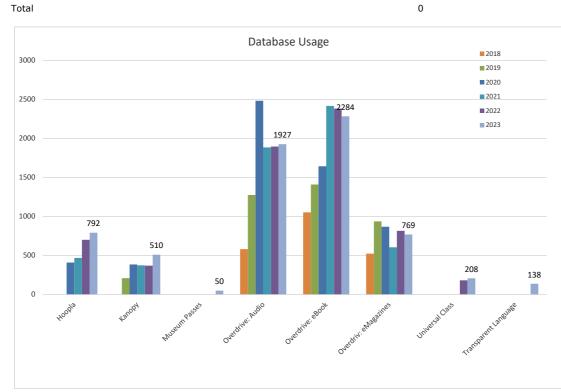
